It is important to let the story come out in fragments, and to join and validate the emotional impact before trying to collect this organizing information. However, this information will be important in locating the detainee, assisting the family and determining if there has been a civil rights violation. The more information we can get from the beginning the faster we can locate the detainee and meet the needs of the family. *All identifying information is confidential.*
